What Is a Point-In-Time (PIT) Count?

An enumeration of unsheltered and sheltered persons experiencing homelessness on one night during the last 10 days of the calendar month of January in our geographical area

It is important to note that the PIT count only identifies a subset of individuals and families that meet HUD's definition of homeless. As such, the PIT count does not capture everybody who is eligible for homeless assistance through HUD or other homeless assistance funding sources.

Who Is Counted?

Individuals and families who are:

- Living on the street, in tents, cars, abandoned buildings
- Emergency shelters
- Transitional housing
- Fleeing domestic violence/DV shelter



 HUD also requires enumeration/estimation of certain key subpopulations: seriously mentally ill, chronic substance abusers, veterans, persons with HIV/AIDS, unaccompanied youth

Why conduct a count?

- Required by the US Dept. of Housing and Community Development (HUD) for all jurisdictions receiving federal funding
- Directs CoC planning to end homelessness
- Demonstrates a need for resources in our Continuum of Care application
- Raises public awareness
- Accurately measures and identifies the needs of the population
- Measures performance in eliminating homelessness

19% increase over last year


Increase in sheltered count

 Attributing factors-Increase in size of families being served; more individuals in ERS; overflow beds being used in some programs; increase in family transitional housing units; SARC exceeded capacity

Increase by two in unsheltered count

 Attributing factors-more effective outreach efforts;


Total Count of Individuals Experiencing Homelessness by Year






Location at Time of PIT Count



of Individuals in Motels and Winter Shelter by Year




of Individuals in Year-Round Emergency Shelter by Year





of Individuals in Transitional Housing by Year





Point-In-Time Count Gender By Year





Point-In-Time Count Age By Year




Sub-Populations (Adults Only)

Point-In-Time Count Sub-Populations by Year




Overall Household Composition

of Single Adult Households per Location the Night of the PIT Count



3% of the adult population were veterans




Unaccompanied Youth (ages 18-24)

There were no unsheltered unaccompanied youth.






Parenting Youth Households

11% of households with children were parenting youth



 An additional 12 individuals were found to be living on the streets that would have been missed if not for this event.

Continuum of Care Snapshot

- On January 23, 2019, there were 375 men, women and children being served in the various housing programs for people experiencing homelessness.
- There are a total of 141 year-round Emergency Shelter and Transitional Housing beds available for men, women and children on any given night of the year.
- There are a total of 148 Permanent Supportive Housing beds for men, women and children on any given night of the year.
- There are up to 55 voucher beds, depending on need and/or weather.
- There are 28 additional safe-house beds.
- There are multiple Rapid Re-Housing units depending on funding (on the night of 1/23/19, there were 11 households/35 persons in RRH)

Coordinated Access Status

- On the night of the PIT count, there were no families with children waiting for shelter on the Family Priority List.
- On the night of the PIT Count, there were 2 adult individuals waiting for shelter on the Single Adult Priority List.
- From January 1, 2019-March 18, 2019, 4 families were placed on the Family Priority List for shelter and 16 single adults on the Single Adult Priority List.
- From January 1, 2019-March 18, 2019, 7 households were identified as at-risk and placed on the At-Risk Priority List, all are Families with children.
